An Earnest Money Deposit (EMD) of Fifty Thousand only (50,000/-) and the non-refundable Tender document cost of 2500/- + V A T (5%), a total of 52,625/- (Fifty Two Thousand Six Hundred and Twenty Five only) shall be remitted as one single transaction and not separate. Separate or split remittance for tender document fee and EMD shall be treated as invalid transactions. Mode of payment other than NEFT /RTGS will not be allowed.

Bidder shall ensure that account number entered during NEFT remittance at any bank counter is the same as it appears in the remittance form generated for that particular bid by the e- Procurement system. Bidder should ensure that tender document fee is remitted only to the account number given in the Remittance form provided by e - Procurement system for that particular tender. Bidder shall ensure the correctness of details entered while remitting through NEFT. No additional information like bidder name, company name, etc. should be entered in the account number column along with account no. for NEFT remittance.

Bidders shall ensure that the remittance confirmation (UTR number) received after NEFT transfer should be updated as it is, without any truncation or addition, in the e-Procurement system for tracking the payment.

All the Tender documents are to be submitted online only and in the designated covers on the above website and no manual submission will be entertained. Originals of Bid Agreement in stamp paper, enclosed in a sealed envelope shall be submitted to the Director, EMC before the date and time mentioned.

The bid shall be opened online at the office of the Energy Management Centre, Sreekrishna Nagar, Sreekaryam, Thiruvananthapuram, 695017, on the date and time mentioned above in the presence of the bidders/ their representatives who wish to attend.
